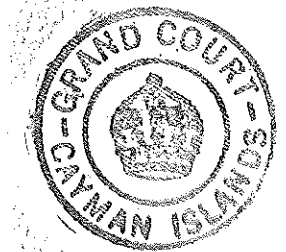

UPON the application by Geoffrey Varga as official liquidator (the "OL") of Lancelot Investors Fund Limited (the "Company") by Summons dated 8 September 2016

AND UPON reading the Sixteenth and Amended Nineteenth Affidavits of Geoffrey Varga sworn on 9 September and 10 October 2016

AND UPON hearing counsel for the OL

IT IS ORDERED THAT

1 Pursuant to Section 4(2) of the Confidential Information Disclosure Law, 2016 that the OL be authorised to disclose certain confidential information concerning the participation of those of the Company's investors set out in the Schedule to this order to the United States District Court for the District of Minnesota in Case no. 09-cv-01750 and to Ronald R. Peterson in his capacity as the court-appointed Receiver (the "Receiver") of the assets of Gregory M. Bell, Lancelot Investment Management LLC, Inna Goldman, the Inna Goldman Revocable Trust and the Gregory Bell Revocable Trust for the purposes of a distribution being made by the Receiver to those investors who suffered a net loss as a result of their investment in the Company;

2 Pursuant to Order 24 rule 6 of the Companies Winding-Up Rules that:

2.1 the Sixteenth and Amended Nineteenth Affidavits of Geoffrey Varga sworn on 9 September and 10 October 2016

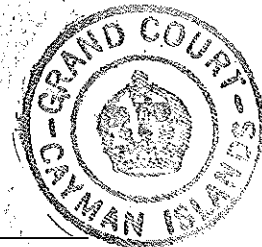

2.2 The Schedule to this order and
