ORDER



UPON HEARING counsel for the official liquidators of Weaving Macro Fixed Income Fund Limited upon their Summonses dated 3 and 4 October 2012

AND UPON READING the Fourth Affidavit of Hugh Dickson of Grant Thornton Specialist Services (Cayman) Limited sworn on 5 October 2012 (together with Exhibit "HD-4") and filed on behalf of himself and Paul McCann of Grant Thornton (Ireland) LLP (referred to as "the GT Liquidators")

AND UPON READING the Tenth Affidavit of Ian Stokoe of PWC Corporate Finance & Recovery (Cayman) Limited (together with Exhibit "IS-10") sworn on 2 October 2012 and filed on behalf of himself and David Walker (referred to as "the Principal Liquidators")

IT IS ORDERED AND DIRECTED that:-

1. The remuneration of the GT Liquidators for the period 1 March to 31 August 2012 in the sum of US\$262,333.61 is hereby approved.
2. The remuneration of the Principal Liquidators for the period from 1 March to 31 August 2012 in the sum of US\$130,485.00 is hereby approved.

3. Both the GT Liquidators and the Principal Liquidators shall, as soon as practicable after receiving approval from the Liquidation Committee, apply for Court approval of their remuneration for the period 1 September 2012 to 28 February 2013.
4. The hearing of the application referred to in paragraph 3 above shall take place on Friday 5 April 2013. .
5. Both liquidators' costs of and incidental to their respective Summonses shall be paid from the assets of the Company as an expense of the liquidation.
