ORDER

UPON the hearing of the Summons issued on 21 May 2013 (the "Summons") on behalf of the Joint Official Liquidators (the "JOLs") of Orchid Developments Group Limited (In Official Liquidation) (the "Company")

AND UPON hearing Counsel for the JOLs

AND UPON reading the Second Affidavit of Eleanor Grace Fisher (the "Affidavit") and correspondence from the "Orchid Action Group (United Kingdom)" transmitted to the JOLs on 24 and 29 May 2013

IT IS ORDERED AND DIRECTED that:

1. The loan of US\$35,000 provided by Bellport Corporation ("Bellport") to the Company be and is hereby sanctioned pursuant to section 110(2) of the Companies Law (2012 Revision).
2. The JOLs' appointment of:
 - (a) Appleby (Cayman) Ltd., as their Cayman Islands attorneys; and


(b) Stephenson Harwood, as their English solicitors

be and is hereby sanctioned pursuant to section 110(2) of the Companies Law (2012 Revision).

3. The relief sought in paragraphs 2(c) and 3 of the Summons sanctioning the appointment of Bellport Corporation (“Bellport”) to assist with the management of the Company, and sanctioning the proposed sale of the Company’s assets as described in the Affidavit, pursuant to section 110(2) of the Companies Law (2012 Revision) be adjourned for further hearing on the first available date in July 2013.
4. The Summons and the Affidavit be served on each creditor and contributory of the Company who has not already been served with the same pursuant to Order 11 rule 2(1)(c) of the Companies (Winding Up) Rules 2008 (as amended).
5. The JOLs’ costs of this application be treated as expenses of the liquidation and paid out of the assets of the Company.
