BY CONSENT IT IS ORDERED THAT:


1. The time specified in paragraph 7 of the Order of the Honourable Justice Jones QC dated 28 May 2015 ("28 May 2015 Order") by which the Defendants are to file and serve their Amended Statement of Defence shall be extended to 4pm on Friday 30 October 2015.
2. The Defendants are to serve their draft Lists of Issues in respect of the Bermuda law, Luxembourg law and New York law issues and to provide the Plaintiff with their comments on the draft Lists of Issues in respect of administration, custodian and quantum issues by 4pm on Friday 6 November 2015.
3. The Plaintiff shall provide the Defendants with its comments on the draft Lists of Issues in respect of the Bermuda law and New York law issues by 4pm on Friday 13 November 2015.
4. The Plaintiff shall provide the Defendants with their draft instructions on the administration, custodian and quantum issues and the Defendants shall provide the

Plaintiff with draft instructions on the Bermuda law, Luxembourg law and New York law issues by 4pm on Friday 20 November 2015.

5. The time specified in paragraph 8 of the 28 May 2015 Order by which the Plaintiff is to file and serve its Amended Reply, if any, shall be extended to 4pm on Friday 20 November 2015.
6. The Plaintiff and Defendants shall use their best endeavours to agree the draft List of Issues and instructions and materials for each of the proposed fields of expert evidence before 4pm on Friday 27 November 2015.
7. The date upon which the Case Management Conference referred to in paragraph 9 of the 28 May 2015 Order is to be restored shall be amended to Wednesday, 16 December 2015.
8. The time specified in paragraph 10 of the 28 May 2015 Order by which the parties are to exchange witness statements, and hearsay notices where required, shall be extended to 4pm on Wednesday, 24 February 2016.
9. The time specified in paragraph 11 of the 28 May 2015 Order by which the parties are to file and serve any reply witness statements shall be extended to 4pm on Friday, 29 April 2016.
10. Costs in the cause.

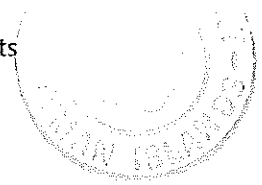
