**UPON** the Court convening a Case Management Conference of its own motion

**AND UPON** hearing counsel for Mr Wael Almazeedi, BTU Power Management Company Ltd, QGEN Industries Ltd and BTU STAEG O&M Services Limited ("the Appellants") and counsel for Mr Stuart Sybersma and Mr Michael Penner of Deloitte & Touche (the "JOLs")

**IT IS ORDERED THAT:**

1. The Appellants' attorneys are to write to the JOLs' attorneys by 1 November 2013 identifying any issues raised in the Appellants four summonses dated 21 June 2013 ("the Appeals") or parts thereof which are not to be pursued;
2. The Appellants shall file and serve evidence in support of the Appeals exhibiting all relevant documents upon which they intend to rely by no later than 3:00pm on 15 November 2013;
3. The JOLs shall file and serve evidence in response exhibiting all relevant documents upon which they intend to rely by no later than 3:00pm on 13 December 2013;
4. The parties shall exchange skeleton arguments by no later than 12:00 noon on 8 January 2014;

5. The parties shall, if so advised, make any application for leave to cross-examine any witness by 20 December 2013;
6. A case memorandum shall be prepared and agreed as far as possible, to include a chronology, dramatis personae, structure chart and a list of issues to be determined, to be filed on or before 12:00 noon on 8 January 2014;
7. Preparation and filing of the hearing bundles shall be agreed and completed in accordance with the FSD Guide no later than 12:00 noon on 8 January 2014;
8. The Appeals will be adjourned to 16 and 17 January 2014 with a time estimate of 2 days;
9. The parties shall have liberty to apply; and
10. Costs in the Cause.
