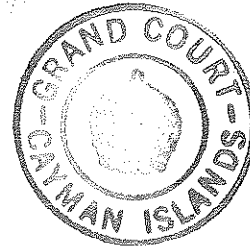

ORDER

UPON HEARING counsel for the official liquidators of Weaving Macro Fixed Income Fund Limited (the "**Company**") upon their Summons dated 12 March 2014

AND UPON READING the Thirteenth Affidavit of Ian Stokoe of PWC Corporate Finance & Recovery (Cayman) Limited (together with Exhibit "IS-13") sworn on 17 March 2014 and the First Affidavit of Elizabeth Budzynski of PWC Corporate Finance & Recovery (Cayman) Limited (together with Exhibit "EB-1") sworn on 26 March 2014, both filed on behalf of Mr. Stokoe and David Walker (referred to as the "**Principal Liquidators**") and on behalf of Hugh Dickson of Grant Thornton Specialist Services (Cayman) Limited and Paul McCann of Grant Thornton (Ireland) LLP (referred to as the "**GT Liquidators**")

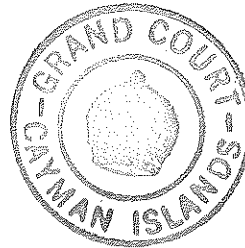

IT IS ORDERED AND DIRECTED that:-

2. The remuneration of the Principal Liquidators for the period 1 September 2013 to 28 February 2014 in the sum of US \$90,863.50 is hereby approved.
3. The remuneration of the GT Liquidators for the period 1 September 2013 to 28 February 2014 in the sums of US\$230,724.00 and €146,520.00 is hereby approved.

4. The remuneration of the Forensics and Investigations Services department of Grant Thornton UK LLP for the period 2 July 2012 to 15 October 2012 in the sum of £136,382.00 is hereby approved.
5. Both the Principal Liquidators and the GT Liquidators shall, as soon as practicable after receiving the approval of the Liquidation Committee, apply for Court approval of their remuneration for the period 1 March 2014 to 31 August 2014.
6. The hearing of the applications referred to in paragraph 3 above shall take place on 17 October 2014.
7. Both Liquidators' costs of and incidental to this Summons shall be paid from the assets of the Company as an expense of the liquidation.
