ORDER

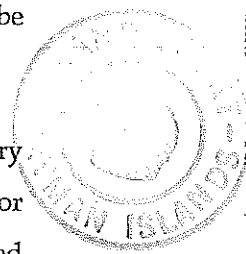
UPON hearing counsel for the parties on the Defendants' summons dated 22 September 2014 (the Summons)

AND UPON reading the First Affidavit of Jill Maria Virgil sworn on 27 August 2014 and Exhibit JMV1 and Third Affidavit of Cecile Jeanne de Chantal Thiry sworn on 22 September 2014 and Exhibit CT3

IT IS ORDERED THAT:

1. The time specified in paragraph 2(a) of the Order for Directions dated 14 January 2014, by which the parties are to give discovery by list of documents in compliance with O.24 r.5, shall be extended to 4pm on Wednesday 31 December 2014.

2. The time specified in paragraph 3 of the Order for Directions dated 14 January 2014, by which any applications pursuant to GCR order 24, rule 16 for orders for oral discovery shall be issued, shall be extended to 4pm on Friday 30 January 2015.
3. The time specified in paragraph 4 of the Order for Directions dated 14 January 2014, by which witness statements, and hearsay notices where required, are to be exchanged shall be extended to 4pm on Thursday 30 April 2015.
4. The time specified in paragraph 6 of the Order for Directions dated 14 January 2014 for the Case Management Conference to be restored for further hearing for the purpose of giving directions in relation to expert evidence shall be amended to a date to be fixed in May 2015.
5. The time specified in paragraph 8 of the Order for Directions dated 14 January 2014 for the listing of the trial shall be amended to Monday, 4 January 2016.
6. The Plaintiff shall file and serve its Amended Statement of Claim by no later than 4pm on Friday, 28 November 2014.
7. Costs in the cause.
