ORDER

UPON reading the letter dated 23 October 2014 and written by Solomon Harris by which they sought to inspect the Court file pursuant to CWR O.26 r.4(1)(e) on behalf of Skandinaviska Endkilda Banken AS publ, ("SEB"), a shareholder of the Company

AND UPON reading the letter dated 14 November 2014 and written by Ogier on behalf of Hugh Dickson and Paul McCann in their capacity as joint official liquidators of the Company by which they seek (a) directions pursuant to GCR O.63 r.4(1)(a) that certain documents be removed from the Court file and (b) directions pursuant to CWR O.24, r.6 that certain documents on the Court file be sealed

AND UPON reading the Second Affidavit of Peter Bigwood sworn on 14 November 2014

AND UPON the Judge having reviewed the Court file

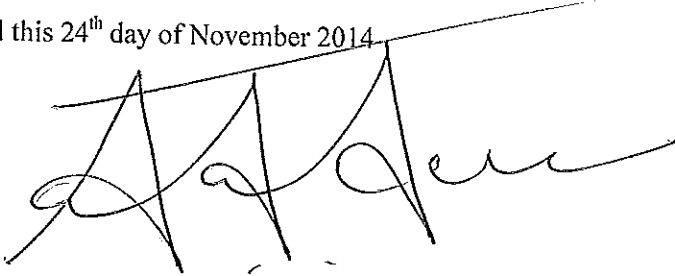
IT IS ORDERED THAT:-

1. An official liquidator's report relating to Santa Clara I Fund (FSD #173/2010) shall be removed from the Court file on the ground that it has been filed in error.
2. All general correspondence (including hard copy letters, prints of e-mails and all enclosures or attachments) passing between the Court, the attorneys acting for the official liquidators and/or other parties shall be (a) removed from the Court file on the grounds that it is not required by GCR O.63 and/or CWR O.24, r.4 to be placed on the Court file and (b) placed on separate electronic and/or physical files which shall be maintained for the use of the Court staff only.

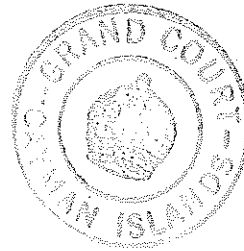
3. The exhibits specified in Schedule 1 to this Order shall be removed from the Court file and returned to the attorneys responsible for filing them on the ground that they have been wrongly filed in breach of GCR O.41, r.9(2).
4. The application to seal (in whole or in part) the documents listed in Schedule 2 is dismissed on the grounds that (a) the application has not been made in a timely manner and (b) the Court is not satisfied that the publication of the documents will harm the economic interests of the creditors or contributories of the Company.
5. The Registrar of the FSD shall notify Ogier and Solomon Harris as soon as she has complied with paragraphs 1 to 3 of this Order, whereupon Solomon Harris shall be permitted to inspect the Court file on behalf of SEB.

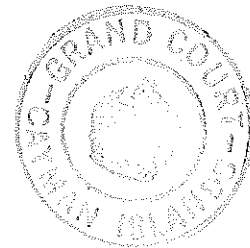
