Developments (In Official Liquidation)


AND UPON READING the e-mail transmitted to the Court from the JOLs' attorneys on 11

IT IS ORDERED that:

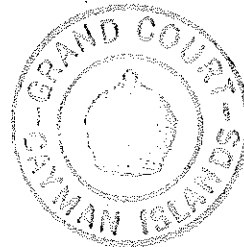
1. Paragraph 2 of the Order made on 8 August 2014 shall be varied in that the JOLs shall
