PARTICULARS OF CLAIM

- 1 The Defendant rented a motor vehicle from the Plaintiff on November 8 2017 and a contract was signed to the agreement of the Rent a Car.
- 2 The M/V was returned on February 17 2018 and at the time the Defendant had a outstanding balance of \$376.00
- 3 The Defendant stated that she would pay off the balance by the end of February.
- 4 In March 2018 no payment was received from the defendant and after numerous phone calls to the Defendant, the defendant continued to make excuses that her boyfriend would pay the balance
- 5 On April 2 the defendant paid a debt collection agency to collect on their behalf.
- 6 Several phone calls were made to the defendant from the debt collector to which a demand letter was delivered to her however the defendant refused to reply to.
- 7 The debt collector informed that all channels failed to collect on this and as such we refer to the court
- 8 As of May 16 2018 the defendant owes the plaintiff \$526.00 (including the debt collector fee)

AND the Plaintiff claims:

- (1) The sum of \$526.00
- (2) Fixed costs of \$150.00, \$25.00 filing fee and process server fee \$125.00 alternatively costs to be assessed.
- (3) Total sum \$826.00
