2. The Defendant is currently indebted to the Plaintiff in respect of a Credit Card Account ending #0009 in the principal sum of US\$1,892.94, plus interest which will continue to accrue at the rate of 18%.
3. The Plaintiff demanded payment of the debt due by a letter from its attorneys dated 13 April 2018. The Defendant has failed to pay the debt due to the Plaintiff.
