WINDING UP PETITION



TO: The Grand Court of the Cayman Islands

The petition of Tay Shau Yin, of 337C Tah Ching Road #01-01, Singapore 613337 (the "**Petitioner**") shows that:

- 1 Lighthouse Liberty Ltd (the "**Company**") was incorporated and registered (registration no. 277865) on 23 May 2013 under the Companies Law (as revised).
- 2 The last known registered office of the Company was Codan Trust Company (Cayman) Limited, Cricket Square, Hutchins Drive, PO Box 2681, Grand Cayman KY1-1111, Cayman Islands.
- 3 The Company was struck off the Register of Companies on 31 October 2017.
- 4 The amount of the reinstatement fee payable upon restoring the Company to the register of companies is CI\$6,466.69.
- 5 The Company is indebted to the Petitioner with respect to the value of certain redeemed corporate bonds issued by the Company, including principal plus interest, in the total amount of SGD153,750.
- 6 The Company was, at the time of the striking off, carrying on business as an investment holding company in Singapore, or it is otherwise just that the Company be restored to the Register of Companies and wound up in accordance with section 159 of the Companies Law (2018 Revision) (the "**Law**").
- 7 Furthermore, it is appropriate that the Company be wound up in accordance with sections 93 and 94 of the Law given that the Company is unable to pay its debts.
- 8 The Petitioner nominates Angela Barkhouse of KRYs Global (Cayman), Governors Square, Building 6, 2nd Floor, 23 Lime Tree Bay Avenue, PO Box 31237, Grand Cayman KY1-1205, Cayman Islands and Jonathan Ong Shyue Wen of KryS & Associates Singapore Pte Ltd, 24

Your Petitioner therefore humbly prays that:

- 1 The Company be restored to the Register of Companies;
- 2 The Company be wound up by the Court;
- 3 Angela Barkhouse of KRyS Global (Cayman), Governors Square, Building 6, 2nd Floor, 23 Lime Tree Bay Avenue, PO Box 31237, Grand Cayman KY1-1205, Cayman Islands and Jonathan Ong Shyue Wen of Krys & Associates Singapore Pte Ltd, 24 Peck Seah Street, #04-01, Nehsons Building, Singapore 079314, be appointed Joint Official Liquidators of the Company; and
- 4 Such other order or directions may be made as the Court thinks fit.
