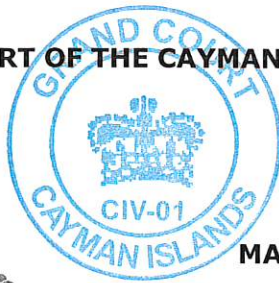

WRIT OF SUMMONS

TO: Leopold Licuana

THIS WRIT OF SUMMONS has been issued against you by the above-named Plaintiff of 54 Nashe Street, Bodden Town, Grand Cayman in respect of the claim set out on the next page.

Within 14 days after the service of this Writ on you, counting the day of service, you must either satisfy the claim or return to the Court Office, P.O. Box 495G, George Town, Grand Cayman, the accompanying Acknowledgment of Service stating therein whether you intend to contest these proceedings.

If you fail to satisfy the claim or to return the Acknowledgment within the time stated, or if you return the Acknowledgment without stating therein an intention to contest the proceedings, the Plaintiff may proceed with the action and judgment may be entered against you forthwith without further notice.

Issued this 13th day of January 2020.

NOTE - This Writ may not be served later than 4 calendar months (or, if leave is required to effect service out of the jurisdiction, 6 months) beginning with the date of issue unless renewed by order of the Court.

STATEMENT OF CLAIM

1. At all material times the Plaintiff was the owner and driver of a Mitsubishi Lancer registration 154 730 and the Defendant was the driver of a Suzuki van registration 145 374.
2. On the 26 April 2017 at approximately 2.50pm, the Plaintiff and Defendant were both travelling along Thomas Russell Way, George Town in an Easterly direction. The Plaintiff was stationary in traffic at the approach to a roundabout in the vicinity of Printers Way, when the Defendant collided with the rear left side of the Plaintiff's stationary vehicle.
3. At all material times the Defendant's vehicle was insured with Cayman First Insurance Ltd who had issued a policy of insurance relating to the vehicle in accordance with the Motor Insurance (Third Party Risks Law).

Particulars of negligence

4. The accident was caused by the negligence of the Defendant in that he;
 - 4.1 drove too fast in all the circumstances;
 - 4.2 failed to keep any or any proper look out;
 - 4.3 failed to see the Plaintiff in time or at all;
 - 4.4 failed to apply his brakes whether in time or at all;
 - 4.5 failed to steer or control his vehicle so as to avoid the said collision;
5. By reason of the aforesaid, the Plaintiff has suffered personal injury, loss and damage.

Particulars of General Damage

6. The Plaintiff's date of birth is the 27th April 1976 and at the date of the accident she was 40 years old.
7. Immediately after the accident, the Plaintiff was taken to the Accident and Emergency Department at George Town Hospital by ambulance.
8. She was aware of pain in her lower back and legs. She underwent x-rays and was prescribed medication.
9. She suffered continued pain and attended with her physicians. She underwent CT scan of her lower back confirming a pars fracture.
10. She commenced physiotherapy at RVC Rehabilitation.
11. She reattended with her physicians with continued back, neck and shoulder pain and underwent further imaging of her cervical spine and right shoulder.

12. She was confirmed as having suffered a full thickness tear of the supraspinatus tendon in her right shoulder and underwent surgery in July 2017.
13. She underwent surgery on her left shoulder in February 2019 to repair a tear.
14. She has undergone facet joint injections in her cervical and lumbar spine.
15. She underwent a L3 to S1 fusion in October 2019 at Health City Cayman Islands.
16. The Plaintiff suffers continued significant discomfort in her neck, shoulders and back. She may require surgery on her cervical spine.
17. The Plaintiff has a history of undergoing L5/S1 spinal fusion in May 2008, she had made a good recovery following this procedure.
18. At the time of the accident the Plaintiff was employed as an account assistant, she attempted to return to work post-accident but was unable to do so. Her employment was terminated in September 2017 and she has not been able to return to employment.

Particulars of Special Damage

19. The Plaintiff's particulars of special damage will be forwarded in due course by way of a Schedule of Loss including but not limited to claims for costs of medical treatment, past and future loss of earnings, travel, health insurance and gratuitous care.
20. The Plaintiff will claim interest pursuant to section 34 of the Judicature Law (2017 Revision) at half the rate as prescribed under the Judgment Debts (Rates of Interest) Rules (as amended) from the 27th April 2017 to Trial.

1. General and Special Damages
2. Interest in accordance with the Judicature Law (2017 Revision)
3. Costs

**DIRECTIONS FOR ACKNOWLEDGMENT OF SERVICE
OF WRIT OF SUMMONS**

1. The accompanying form of Acknowledgment of Service should be completed by an Attorney acting on behalf of the Defendant or by the Defendant if acting in person.

After completion it must be delivered or sent by post to the Law Courts, P.O. Box 495G, George Town, Grand Cayman.

2. A Defendant who states in his Acknowledgment of Service that he intends to contest the proceedings must also serve a defence on the Attorney for the Plaintiff (or on the Plaintiff if acting in person).

If a Statement of Claim is indorsed on the Writ (i.e. the words "Statement of Claim" appear on the top of page 2), the Defence must be served within 14 days after the time for acknowledging service of the Writ, unless in the meantime a summons for judgment is served on the Defendant.

If the Statement of Claim is not indorsed on the Writ, the Defence need not be served until 14 days after a Statement of Claim has been served on the Defendant.

If the Defendant fails to serve his defence within the appropriate time, the Plaintiff may enter judgment against him without further notice.

3. A Stay of Execution against the Defendant's goods may be applied for where the Defendant is unable to pay the money for which any judgment is entered. If a Defendant to an action for a debt or liquidated demand (i.e. a fixed sum) who does not intend to contest the proceedings states, in answer to Question 3 in the Acknowledgment of Service, that he intends to apply for a stay, execution will be stayed for 14 days after his Acknowledgment, but he must, within that time, issue a Summons for a stay of execution, supported by an affidavit of his means. The affidavit should state any offer which the Defendant desires to make for payment of the money by instalments or otherwise.

Notes for Guidance

1. Each Defendant (if there are more than one) is required to complete an Acknowledgment of Service and return it to the Courts Office.
2. For the purpose of calculating the period of 14 days for acknowledging service, a writ served on the Defendant personally is treated as having been served on the day it was delivered to him.
3. Where the Defendant is sued in a name different from his own, the form must be completed by him with the addition in paragraph 1 of the words "sued as (the name stated on the Writ of Summons)".
4. Where the Defendant is a FIRM and an attorney is not instructed, the form must be completed by a PARTNER by name, with the addition in paragraph 1 of the description "Partner in the firm of (.....)" after his name.
5. Where the Defendant is sued as an individual TRADING IN A NAME OTHER THAN HIS OWN, the form must be completed by him with the addition in paragraph 1 of the description "trading as (.....)" after his name.
6. Where the Defendant is a LIMITED COMPANY the form must be completed by an Attorney or by someone authorised to act on behalf of the Company, but the Company can take no further step in the proceedings without an Attorney acting on its behalf.
7. Where the Defendant is a MINOR or a MENTAL PATIENT, the form must be completed by an Attorney acting for a guardian ad litem.
8. A Defendant acting in person may obtain help in completing the form at the Courts Office.

Attorney: where the Defendant is represented by an attorney, state the attorney's place of business in the Cayman Islands. A Defendant may not act by a foreign attorney.

Defendant in person: where the Defendant is acting in person, he must give his post office box number and the physical address of his residence or, if he does not reside in the Cayman Islands, he must give an address in Grand Cayman where communications for him should be sent. In the case of a limited company, "residence" means its registered or principal office.
