**ORDER**

---

**UPON** the parties attending the pre-trial review of the trial listed for 8-19 March 2021 (the “**Trial**”)  
**AND UPON** hearing from Leading Counsel for the Petitioner and Leading Counsel for the Respondent  
**IT IS HEREBY ORDERED** that:

- 1 The parties shall file and exchange skeleton arguments by no later than 4pm on 1 March 2021.
- 2 The Trial shall proceed in accordance with the timetable included at tab 3 of the PTR hearing bundle subject to any further directions of the Court.
- 3 The Petitioner’s Leading Counsel be granted leave to attend the Trial remotely by video-link.
- 4 The parties shall have permission for their witnesses-of-fact to attend Court for the purposes of cross-examination remotely by video-link from the offices of McGuireWoods in Richmond, Virginia and the parties shall make arrangements for their respective witnesses to be available in accordance with the trial timetable subject to any further directions of the Court.
- 5 The Trial shall be conducted remotely via Zoom and all persons required to attend the Trial shall do so via Zoom.
- 6 Individuals from Deloitte and Opus2 shall be permitted to attend the Trial via Zoom for the purpose of providing courtroom presentation services and real time transcription services respectively. Each of those parties shall be permitted to take a recording of the hearing provided that any such recording is preserved and made available to the Court and the parties upon request.
- 7 The Petitioner shall arrange for a live stream of the Trial to Courtroom 6 where members of the public may have access for observation only.
