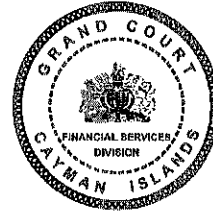

ORDER

---

**UPON** the winding up petition presented on 28 January 2021 by Amissima Assicurazioni Multi-Strategy Fund, a Sub-Fund of Amissima Diversified Income ICAV, Amissima Vita Multi-Credit Strategy Fund, a Sub-Fund of Amissima Diversified Income ICAV, Multi Credit Strategy, a compartment of Athora Lux Invest S.C.Sp and Tranquilidade Multi-Credit Strategy Fund, a Sub-Fund of Tranquilidade Diversified Income ICAV (together the "**Petitioners**") seeking an order that BAF Latam Credit Fund (the "**Fund**") be wound up (the "**Petition**")

**AND UPON** the Fund's application dated 9 February 2021 seeking orders, *inter alia*, that the Petition be dismissed (the "**Dismissal Application**")

**AND UPON** the Petitioners' application dated 12 February 2021 seeking orders, *inter alia*, that the Petitioners be substituted by BNP Paribas Securities Services Luxembourg ("**BNP**") and that the Petition be amended accordingly pursuant to Order 24, rule 1 of the Companies Winding Up Rules, 2018 (CWR) and Order 20 of the Grand Court Rules (as revised) in the form of the amended petition exhibited to the second affidavit of Brigitte Posch sworn on 12 February 2021 (the "**Amended Petition**") (the "**Amendment Application**")


**IT IS ORDERED THAT:**

1. The Dismissal Application is dismissed.
2. BNP be substituted in place of the Petitioners as the petitioner in these proceedings.
3. The Petition be amended in the form of the Amended Petition.

4. The requirement to serve a Summons for Directions on the Fund, pursuant to Orders 3, rule 11 of the CWR, be dispensed with and the Summons for Directions filed in these proceedings and dated 27 January 2021 be treated as the Summons for Directions in relation to the Amended Petition.
5. The Petitioners' costs of the Dismissal Application and the Amendment Application be paid by the Fund, to be taxed on the standard basis if not agreed.


