- a) within six months of the grant to me of probate of the said will, I will prepare a true inventory of the said estate and exhibit and file the same in the Probate Registry; and
- b) within one year of such grant to me, I will administer the said estate according to the tenor of the will and the directions, if any, of the courts and file in the Probate Registry a general account accounting for the whole of the assets of the said estate.

ELIZABETH ANNE KEY


I, **ELIZABETH ANNE KEY** of 11 Sand Cay, 950 South Church Street, George Town, Grand Cayman, Cayman Islands revoke all former Wills and Testamentary dispositions made by me in the Cayman Islands and I declare that this Will shall be my last will and testament and relates only to assets in the Cayman Islands.

1. I declare that I am a resident of the Cayman Islands.
2. I hereby appoint and nominate my daughter, **CAROLINE BARTON** (nee Key) of 11 Sand Cay, 950 South Church Street, George Town, Grand Cayman, Cayman Islands to be the Executrix and Trustee of this my Will, (hereinafter referred to as "my Trustee").
3. I **DIRECT** that as soon as possible after my decease my Trustee shall pay all my just debts, funeral, and testamentary expenses on the express understanding that all such payments are recoverable from my estate.
4. I **REQUEST** that after my decease I be cremated.
5. I **GIVE DEVISE AND BEQUEATH** all of my shares in Caribbean Utilities Company Ltd, Grand Cayman, Cayman Islands to my daughter **CAROLINE BARTON** absolutely.
6. I **GIVE DEVISE AND BEQUEATH** all my real and personal property wherever situate in the Cayman Islands ("my Estate") to my daughter **CAROLINE BARTON** absolutely.
7. If my said daughter shall predecease me or shall not survive me for a period of twentyone (21) days then I **GIVE DEVISE AND BEQUEATH** my Estate to my

grandchildren and if more than one in equal shares PROVIDED ALWAYS that in these circumstances it is my wish that my nephew TRAVIS SPENCER of 21-22 Telegraph Track, Carshalton, Greater London SM5 4AU, England shall hold my Estate on trust for my grandchild or grandchildren until each shall reach the age of eighteen (18) years.


8. This Will shall be governed and construed in accordance with the laws of the Cayman Islands
