ORDER

UPON the Court reading the application of Hugh Dickson and John Royle as the Court-appointed Joint Receivers (the **Receivers**) of the share in Britannia Holdings (2006) Limited (the **Share** and **BH06** respectively) by Summons dated 24 May 2021 (the **Summons**)

AND UPON reading the Eleventh Affidavit of John Paul Royle sworn on 24 May 2021 together with the exhibit thereto

AND UPON READING the letters from Mourant dated 25 May 2021 to Walkers and the attorneys for other parties and dated 8 June 2021 to the Court

IT IS HEREBY ORDERED that:

1. the Joint Receivers' remuneration, including their costs, fees and disbursements for the period 1 April 2020 to 31 March 2021 (the **Period**) as set out in this eleventh affidavit of John Paul Royle dated 24 of May 2021, in the sum of US\$583,203.50 together with their additional fees, costs and disbursements in the sum of US\$300,849.25 incurred in the Period, be approved by the Court.
2. the Joint Receivers' remuneration, costs, fees and disbursements as approved by the Court be paid out of the assets of BH06.
3. the Joint Receivers' costs of and incidental to this Summons for approval of their remuneration, costs, fees and disbursements be paid out of the assets of BH06; and
4. such further order or other relief as the Court may deem appropriate.
