**ORDER**

**UPON THE APPLICATION** dated 29 June 2021 of **SO KIT YEE ANITA** of Ernst & Young Transactions Limited of 22<sup>nd</sup> Floor, CITIC Tower, 1 Tim Mei Avenue, Central, Hong Kong, **ROY BAILEY** of Ernst & Young Ltd, 4<sup>th</sup> Floor, Ritter House, Wickhams Cay 2, Road Town, Tortola, British Virgin Islands VG1110 and **TAMMY KARINA FU** of EY Cayman Ltd, 62 Forum Lane, Camana Bay, P.O. Box 510, Grand Cayman KY11106, Cayman Islands, who were appointed as the joint provisional liquidators of Century Sunshine Group Holdings Limited (In Provisional Liquidation) (the **Company**) by order of this Honourable Court dated 14 July 2020 (the **JPLs**).

**AND UPON** reading the Seventh Affidavit of Tammy Karina Fu and the Eighth Affidavit of Tammy Karina Fu and the Exhibits thereto

**AND UPON** the Court noting that the Creditors' Committee of the Company has not objected to the remuneration of the JPLs for the period 14 July 2020 to 2 April 2021 in the amount of US\$981,044.00

**AND UPON** the Court noting the Company's objection to the JPLs' claimed remuneration and its request that the approved amount be reduced from US\$981,044.00 to US\$980,269.00

**AND UPON** the Honourable Justice Parker considering the application suitable to be disposed of on the papers without the need for an oral hearing

**IT IS HEREBY ORDERED** as follows:

1. The remuneration of the JPLs for the period 14 July 2020 to 2 April 2021 is approved in the amount of US\$980,269.00.

2. That until further order, the Seventh Affidavit of Tammy Karina Fu and Exhibit TKF-7 be sealed and kept confidential.
3. The costs of and incidental to this Summons be paid out of the assets of the Company as an expense of the provisional liquidation.
