PARTICULARS OF CLAIM

1. Between January to April 2021, the Plaintiff paid the defendant a sum of CI \$7,491.00 for architectural house plans to which he agreed would be completed and submitted to the CAYMAN ISLANDS DEPARTMENT OF PLANNING by April 2021. The initial drawings of the house plan were prepared and submitted.
 2. By August 2021, the Plaintiff had not heard from the defendant regarding the remaining plans (building/electrical/plumbing etc) and so contacted the defendant to which he responded he would provide a copy "this week". The defendant is now ignoring the Plaintiff's calls and messages. The Plaintiff is seeking funds paid to be returned for services not provided.
