1. In October 2019 the defendant borrowed ci\$80.00 to pay his utility bills.

9. August 31, 2020 defendant borrowed JA\$80,000.00 (ci\$500) to pay bills in Jamaica.
10. September 03, 2020 defendant borrowed JA\$150,000.00 (ci\$950) to pay court fee.
11. September 10. 2020 defendant borrowed ci\$500.00 to pay lawyer
12. December 2020 defendant borrowed Ja\$60,000.00 (ci\$375) to pay for car rental
