**The Petition of the joint voluntary liquidators of IMOF LT Investors Ltd. of Kensington House, 69 Dr Roy's Drive, P.O Box 2510, Grand Cayman, KY1-1104, the Cayman Islands**

1. IMOF LT Investors Ltd. (the "**Company**") was incorporated and registered (registration no. 284952) on 6 February 2014 under the Companies Law.
2. The registered office of the Company is Stuarts Corporate Services Limited, P.O Box 2510, Kensington House, 69 Dr Roy's Drive, George Town, Grand Cayman, KY1-1104, the Cayman Islands.
3. On 13 May 2020, the Company's sole shareholder resolved to put the Company into voluntary liquidation
4. On 12 June 2020, the Company's sole shareholder resolved to recall the voluntary liquidation and for the Company to be placed back in good standing under s.111(2) Companies Act (2020 Revision).
5. The recall of the voluntary liquidation has not to date been progressed and no Order has been made in that respect. As such, the Company remains in voluntary liquidation.

6. On 3 November 2021, the Company's sole shareholder instead resolved that the voluntary liquidation of the Company should now continue and the recall of the voluntary liquidation should not proceed.

The petitioner therefore prays that:

1. The request to the Registrar of Companies to reinstate the Company be discontinued;
2. The voluntary liquidation of the Company be allowed to proceed forthwith;
3. The Joint Voluntary Liquidators shall publish a notice in the Cayman Islands Gazette advertising the continuation of the voluntary liquidation and providing the details for the final general meeting of the Company.
4. There be no order as to costs.
