**THIS WRIT OF SUMMONS** has been issued against you by the above-named Plaintiff of 146 Botanic Park Road, Grand Cayman in respect of the claim set out on the next page.

Within 14 days after the service of this Writ on you, counting the day of service, you must either satisfy the claim or return to the Court Office, P.O. Box 495G, George Town, Grand Cayman, the accompanying Acknowledgment of Service stating therein whether you intend to contest these proceedings.

If you fail to satisfy the claim or to return the Acknowledgment within the time stated, or if you return the Acknowledgment without stating therein an intention to contest the proceedings, the Plaintiff may proceed with the action and judgment may be entered against you forthwith without further notice.

NOTE - This Writ may not be served later than 4 calendar months (or, if leave is required to effect service out of the jurisdiction, 6 months) beginning with the date of issue unless renewed by order of the Court.

**STATEMENT OF CLAIM**

1. At all material times the Plaintiff was the driver of a Honda Accord registration 168 172 and the Defendant was the driver of a Toyota bearing registration number 144 915.
2. On 22 March 2019 at approximately 4.55pm, the Plaintiff was driving on the roundabout in the proximity of the Lion's Centre heading in an Easterly direction when the Defendant pulled onto the roundabout and into the side of the Plaintiff's correctly proceeding vehicle.

**Particulars of negligence**

3. The Defendant was negligent in that he:
  - (a) failed to keep any or any proper look out;
  - (b) failed to give way;
  - (c) failed to see the Plaintiff in time or at all;
  - (d) pulled onto a roundabout when it was unsafe to do so;
  - (e) failed to apply his brakes whether in time or at all;
  - (f) failed to steer or control her vehicle so as to avoid the said collision;
4. The Plaintiff will rely on the doctrine of res ipsa loquitor.
5. By reason of the aforesaid, the Plaintiff has suffered personal injury, loss and damage.

**Particulars of Injury**

6. The Plaintiff's date of birth is the 26 December 1969 and at the date of the accident, the plaintiff was 49 years old.
7. The Plaintiff was immediately aware of lower back pain. She went home and self-medicated, but the pain increased, and she therefore attended the Accident and Emergency Department of George Town Hospital on the 26 March 2019 suffering from lower back, hip and chest pain and some numbness to her left foot. She was examined, underwent x-rays of the lumbar spine and advised on medication.
8. She attended with the GP at the hospital on the 30 March 2019 with continued lower back pain radiating into her foot. She was referred for MRI, to pain management and for physiotherapy.
9. She reattended with the GP the hospital on the 6 April 2019 with continued severe lower back pain. She was referred for MRI and advised on pain medication.
10. She had to travel to the United States and continued to suffer significant pain to her neck and back and so attended the Emergency department at Baptist Hospital on the 22 June 2019. She underwent imaging of her cervical, thoracic and lumbar spine and was given further medication and provided advice on back exercises.

11. She attended for assessment with Tenson Edmonds of Rehoboth Physio and Paincare on the 10 July 2019. He recommended she undergo chiropractic manipulation, manual therapy, heat treatment and electrical stimulation.
12. She attended the hospital on the 10 September 2019 with continued back pain and was referred for private physiotherapy.
13. She underwent MRI on the 2 October 2019 which showed an annular disc bulge and disc protrusion.
14. She underwent chiropractic and physiotherapy treatment at Synergy in early 2020.
15. She underwent further MRI of lumbar and thoracic spine in January 2021 which showed facet joint synovitis consistent with a sprain injury, disc bulge and disc herniation.
16. The plaintiff still suffers discomfort in her back and requires continued treatment.
17. Further particulars of the Plaintiff's injury and treatment will be provided at a later date by way of a schedule of damages.

#### **Particulars of Special Damage**

18. The Plaintiff's particulars of special damage will be supplied at a later date by way of a schedule of damages including but not limited to claims for medical treatment, travel and gratuitous care.

**DIRECTIONS FOR ACKNOWLEDGMENT OF SERVICE  
OF WRIT OF SUMMONS**

1. The accompanying form of Acknowledgment of Service should be completed by an Attorney acting on behalf of the Defendant or by the Defendant if acting in person.

After completion it must be delivered or sent by post to the Law Courts, P.O. Box 495G, George Town, Grand Cayman.

2. A Defendant who states in his Acknowledgment of Service that he intends to contest the proceedings must also serve a defence on the Attorney for the Plaintiff (or on the Plaintiff if acting in person).

If a Statement of Claim is indorsed on the Writ (i.e. the words "Statement of Claim" appear on the top of page 2), the Defence must be served within 14 days after the time for acknowledging service of the Writ, unless in the meantime a summons for judgment is served on the Defendant.

If the Statement of Claim is not indorsed on the Writ, the Defence need not be served until 14 days after a Statement of Claim has been served on the Defendant.

If the Defendant fails to serve his defence within the appropriate time, the Plaintiff may enter judgment against him without further notice.

3. A Stay of Execution against the Defendant's goods may be applied for where the Defendant is unable to pay the money for which any judgment is entered. If a Defendant to an action for a debt or liquidated demand (i.e. a fixed sum) who does not intend to contest the proceedings states, in answer to Question 3 in the Acknowledgment of Service, that he intends to apply for a stay, execution will be stayed for 14 days after his Acknowledgment, but he must, within that time, issue a Summons for a stay of execution, supported by an affidavit of his means. The affidavit should state any offer which the Defendant desires to make for payment of the money by instalments or otherwise.

**Notes for Guidance**

1. Each Defendant (if there are more than one) is required to complete an Acknowledgment of Service and return it to the Courts Office.
2. For the purpose of calculating the period of 14 days for acknowledging service, a writ served on the Defendant personally is treated as having been served on the day it was delivered to him.
3. Where the Defendant is sued in a name different from his own, the form must be completed by him with the addition in paragraph 1 of the words "sued as (the name stated on the Writ of Summons)".
4. Where the Defendant is a FIRM and an attorney is not instructed, the form must be completed by a PARTNER by name, with the addition in paragraph 1 of the description "Partner in the firm of (.....)" after his name.
5. Where the Defendant is sued as an individual TRADING IN A NAME OTHER THAN HIS OWN, the form must be completed by him with the addition in paragraph 1 of the description "trading as (.....)" after his name.
6. Where the Defendant is a LIMITED COMPANY the form must be completed by an Attorney or by someone authorised to act on behalf of the Company, but the Company can take no further step in the proceedings without an Attorney acting on its behalf.
7. Where the Defendant is a MINOR or a MENTAL PATIENT, the form must be completed by an Attorney acting for a guardian ad litem.
8. A Defendant acting in person may obtain help in completing the form at the Courts Office.
