- 2) within one year of such grant to me, I will administer the said estate according to the tenor of the Will and directions, if any, of the Court and file in the Probate Registry a general accounting for the whole of the assets of the said estate.

And I declare myself (and my successors) to be bound unto the Financial Secretary of the Islands in the sum of US\$6,000.00.

The condition of this obligation is that if the above-named does, when lawfully called upon in that behalf, make or cause to be made a true and perfect inventory of the said estate and does exhibit the same in the Probate Registry whenever lawfully called upon so to do and do well and truly administers the said estate according to law and the tenor of the will and does make or cause to be made a just account and distribution account thereof whenever lawfully so required, then this obligation shall be void and of no effect, but shall otherwise remain in full force and effect.
