CONSENT ORDER

UPON the Order of Henderson J dated 24 July 2009 granting an injunction against the 1st to 43rd Defendants (the **Worldwide Freezing Order** and the **WFO Defendants**)

AND UPON the Order of Henderson J dated 4 February 2010 (the **Fortification Order**)

AND UPON the Order of the Court of Appeal dated 19 April 2011 in CICA Cause No. 1 of 2010 on appeal from these proceedings setting aside the **Worldwide Freezing Order** against certain of the **WFO Defendants**

AND UPON the Consent Order between the remainder of the **WFO Defendants** and the Plaintiff dated 24 September 2011 (the **WFO Discharge Consent Order**), discharging the **Worldwide Freezing Order** against the remainder of the **WFO Defendants**

AND UPON it having been ordered by consent on 3 June 2021 that the sum of US\$1,116,023.12 plus judgment interest at 2.375% in the sum of US\$15,540.35 as at 13 May 2021 and accruing at US\$72.62 per day be paid to the client account of Maples and Calder, thus satisfying the liabilities of the Plaintiff to the 3rd, 5th, 6th, 7th, 9th-12th, 20th-29th and 38th to 43rd Defendants (the **Maples Defendants**) in respect of its undertakings under Schedule B of the Worldwide Freezing Order

AND UPON the 30th Defendant (also a party to the consent order dated 3 June 2021) having no claim for damages or other losses incurred as a result of the Worldwide Freezing Order and/or pursuant to the Plaintiff's undertakings under Schedule B of the Worldwide Freezing Order

AND UPON it appearing by the signatures of the Attorneys for the Plaintiff, the Attorneys for the Maples Defendants, the Attorneys for the 13th to 19th Defendants (the **AwalCos**) and the Attorneys for the 30th Defendant

IT IS ORDERED BY CONSENT that:

1. The balance of the money which is held pursuant to paragraph 2 of the Fortification Order (**Remaining Fortification Monies**) shall be paid to the account of Awal Finance Company (No. 2) Limited at RBC Royal Bank (Cayman) Limited with account number 733-365-1 (the **AFCL2 Account**) within 7 days of the date of this Order in full and final settlement of the liabilities of the Plaintiff to the AwalCos in respect of their damages and/or other losses incurred as a result of the Worldwide Freezing Order and the Plaintiff's undertakings under Schedule B of the Worldwide Freezing Order.

2. No order as to costs.
