3. The Applicants shall file and serve evidence in reply (if any) by 4.00pm on 21 July 2022, being 14 days thereafter.
4. All parties shall exchange skeleton arguments by 4.00pm on 4 August 2022, together with electronic copies of all authorities relied upon (to allow the Applicants to prepare an agreed authorities bundles).
5. The Applicant shall serve the Respondents with electronic copies of the agreed hearing bundle and the agreed authorities bundle by 4.00pm on 11 August 2022 to allow for cross-referencing of skeleton arguments.
6. Cross-referenced skeleton arguments shall be filed and served by all parties by 4.00pm on 15 August 2022.
7. The agreed hearing bundle, the agreed authorities bundle and an attendance list shall also be filed by the Applicants with the Personal Assistant of the Judge and served on the Respondents by 4.00pm 15 August 2022. The parties are not obliged to file an agreed chronology or dramatis personae.
8. The hearing of the Summons shall be listed for one day on the first available date convenient to the parties after Monday 22 August 2022.
