PARTICULARS OF CLAIM

(Here set out in numbered paragraphs the grounds upon which the Plaintiff claims that the Defendant is indebted to him or is liable to pay damages to him)

- 1 On June 6 2022, 2022 the Defendant borrowed \$4,362.00 from the Plaintiff and agreed to pay back the full amount plus 20% of the amount borrowed by June 27, 2022, of a total of \$5,234.00
- 2 A contract was signed between the Plaintiff and the defendant fully explaining the terms and conditions including the late fees and legal action. to which the defendant stated that she fully understood. The Defendant has borrowed from us on several occasions
- 3 On June 27, 2022, the defendant called and stated that she could not make any payments as she was in Honduras She was informed of the late fee and interest. The Plaintiff agreed to the new balance and signed said contract for the balance to be paid on July 22, 2022, \$6,595.00.
- 4 On July 22, 2022, the defendant came to our office and informed us that she was unable to pay until July 29 at which time she would pay \$2,000.00 towards the balance and every month \$1,500.00 a month until December 2022 and in January 2022 make the final payment of \$1,440.00 a promissory agreement was signed.
- 5 On Wednesday July 27 the plaintiff called the defendant and the defendant informed that everything was ok, and she would be making the payment first thing Friday morning July 29, 2022.
- 6 On Friday July 29, 2022, the plaintiff contacted the defendant, and the defendant informed the plaintiff that she would make the said payment of \$2,000.00 by 2pm after she finish work. At 4:30 the plaintiff WhatsApp the defendant concerning the payment to which the defendant told the plaintiff go ahead and take me to court
- 7 As of Wednesday August 3, 2022, the Defendant has an outstanding balance of \$6595.00, \$50.00 late fee for the first day late as per contract, 20% added to the total balance for 5 days late and as per contract 50% to be added to the balance total \$11,961.00 and simple interest at 2.75% \$0.91 per day

AND the Plaintiff claims:

- (1) The sum of \$11,961.00
- (2) Fixed costs of \$175.00, \$25.00 filing fee and process server fee \$125.00 alternatively costs to be assessed.
- (3) Interest at \$0.91 per day
- (4) Total sum \$12,286.00
