STATEMENT OF CLAIM

1. The Plaintiff is an Attorney-at-Law with Law Office at Elizabethan Square on 80 Shedden Road, George Town, Grand Cayman.
2. The Defendants are Restaurant owners carrying on business in the Plaza at Savannah, Grand Cayman.
