**CONSENT ORDER**

---

**UPON** application by way of Notice of Motion, dated 23 March 2022 (“the **Notice of Motion**”), of the Fifth Defendant claiming the First and Ninth Defendants (“the **Trustees**”) breached the terms of the proprietary injunction dated 17 October 2017 (as subsequently amended) (“the **Injunction**”) by entering into a litigation funding agreement on 22 June 2018 (“the **LFA**”).

**AND UPON** the court hearing the summons issued by the Fifth Defendant on 22 April 2022 (“the **Summons**”) seeking orders inter alia that the Trustees produce the LFA for inspection.

**AND UPON** the Judgment of this Court handed down on 31 May 2022.

**AND UPON** the Order of this Court sealed on 8 July 2022 (the “**Order**”), ordering that the Trustees produce a redacted version of the LFA (on the terms set out in the Order) for inspection by the Fifth Defendant.

**AND UPON** the Trustees producing to the Fifth Defendant a redacted copy of the LFA (the “**Redacted LFA**”) on 11 July 2022 pursuant to the Order.

**AND UPON** the Judgment of this Court handed down on 12 August 2022

**IT IS BY CONSENT ORDERED THAT:**

1. Subject to paragraph 2 below, the Trustees shall produce to the Plaintiffs a copy of the Redacted LFA within 5 days of this order being sealed.
2. For the avoidance of doubt, insofar as the Redacted LFA is disclosed to the Plaintiffs pursuant to paragraph 1 hereof, the Plaintiffs may not, without the permission of the court, rely upon the Redacted LFA in any other proceedings, in any jurisdiction, nor provide the Redacted LFA to any other person save to the Plaintiffs’ legal team, consisting of Walkers and the Plaintiffs’ counsel, for the purpose of the proper conduct of these proceedings.
