2. As at 24 October 2022 the Defendant was indebted to the Plaintiff in respect of a Visa Business Card #4440-9100-2553-0015 in the principal sum of US\$13,163.82 plus the interest which will continue to accrue at a rate of US\$7.31 the per diem.
3. The Plaintiffs has made written demand for repayment by letter from its attorneys but the Defendant has failed to repay the said sum.

**AND THE PLAINTIFF CLAIMS AGAINST THE DEFENDANT:**

1. Payment of the total sum of US\$13,163.82;
2. Contractual interest on the above principal sum at the rate of US\$7.31 per diem and continuing until payment at the same rate pursuant to the Plaintiff's standard banking terms and conditions.
