ORDER

UPON the Petitions dated 1 November 2022 presented against Touradji Private Equity Onshore Fund Ltd (in Voluntary Liquidation), Touradji Private Equity Offshore Fund Ltd (in Voluntary Liquidation), and Touradji Private Equity Master Fund Ltd (in Voluntary Liquidation) (collectively, the “**Petitions**”, the “**Proceedings**”), in each case an exempted company with Michael Pearson and Nicola Cowan of FFP Limited acting as Joint Voluntary Liquidators (“**JVLs**”);

AND UPON a Summons for Directions in each of the Proceedings being listed for hearing together;

AND UPON the Court being satisfied that the Petitions have been served on Touradji Capital Management L.P., which is the management shareholder of each company, as well as all participating shareholders in the Master Fund;

AND UPON hearing from Counsel for the Petitioners in FSD Causes 244 and 245 of 2022 (IKJ), and Counsel for the JVLs who are Petitioners in FSD Cause 246 of 2022 (IKJ);

It is ORDERED that:-

1. The Proceedings be consolidated and case-managed together in accordance with O.4, r.4 of the Grand Court Rules.
2. The Petitions be heard together on 14 December 2022 at 10 a.m.
3. Further service of the Petitions be dispensed with.

4. Advertisement of the hearing of the Petitions be dispensed with.
5. Each Petitioner's costs be in the relevant Petition.
