
**APPLICATION FOR GRANT OF PROBATE OF A WILL

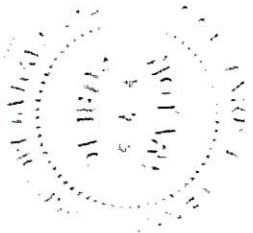
