Within 14 days after the service of this Writ on you, counting the day of service, you must either satisfy the claim or return to the Court Office, P.O. Box 495G, George Town, Grand Cayman, the accompanying Acknowledgment of Service stating therein whether you intend to contest these proceedings.

If you fail to satisfy the claim or to return the Acknowledgment within the time stated, or if you return the Acknowledgment without stating therein an intention to contest the proceedings, the Plaintiff may proceed with the action and judgment may be entered against you forthwith without further notice.

GENERAL INDORSEMENT


1. The Plaintiff is a company incorporated in the Commonwealth of The Bahamas as an International Business Company. The First Defendant is a company incorporated in the Cayman Islands and is in voluntary liquidation. The Second Defendant is a segregated portfolio company incorporated in the Cayman Islands. Victory Asset Management (**VAM**) is a company incorporated in the Cayman Islands which following the execution of a Sale and Purchase Agreement between the Plaintiff and VAM, all relevant assets were transferred and/or assigned to the Plaintiff.
2. The Plaintiff's claims are for loss and damage arising from unpaid sums pursuant to contracts/agreements between VAM and the Defendants including, but not limited to, the Investment Management Agreement and the Offering Supplement contracts. The Plaintiff further claims against the First and Second Defendants for: (a) breach of contract; (b) lawful means conspiracy (further or alternatively unlawful means conspiracy) between the First and Second Defendants, and/or others including Mr Dermot Butler, Mr Kevin Caruana, Mr Richard Reinert, Mr Ian Doran and Mr Stephen Doran.
3. The Plaintiff claims against the First Defendant for: (a) unlawful interference in the agreements/contracts between VAM and the Second Defendant; (b) procuring a breach of the agreements/contracts between VAM and the Second Defendant.
4. The Plaintiff claims against the Second Defendant for: (a) unlawful interference in the agreements/contracts between VAM and the First Defendant; (b) procuring a breach of the agreements/contracts between VAM and the First Defendant.
5. The Plaintiff also claims against the Defendants for Interest on all damages in accordance with Section 34 of the Judicature Act (2021 Revision) at such rate as the Court deems appropriate, alternatively contractual interest, such further or other relief as the Court deems fit, together with costs.

The Plaintiff's claims are for:

- (1) Damages;
- (2) Pre-Judgment interest in accordance with Section 34 of the Judicature Act (2021 Revision);
- (3) Post-Judgment interest in accordance with Section 34 of the Judicature Act (2021 Revision);
- (4) Costs; and
- (5) Such further or other relief as the Court deems just.

**DIRECTIONS FOR ACKNOWLEDGMENT OF SERVICE
OF WRIT OF SUMMONS**

1. The accompanying form of Acknowledgment of Service should be completed by an Attorney acting on behalf of the Defendant or by the Defendant if acting in person.

After completion it must be delivered or sent by post to the Law Courts, P.O. Box 495G, George Town, Grand Cayman.

2. A Defendant who states in his Acknowledgment of Service that he intends to contest the proceedings must also serve a defence on the Attorney for the Plaintiff (or on the Plaintiff if acting in person).

If a Statement of Claim is indorsed on the Writ (i.e. the words "Statement of Claim" appear on the top of page 2), the Defence must be served within 14 days after the time for acknowledging service of the Writ, unless in the meantime a summons for judgment is served on the Defendant.

If the Statement of Claim is not indorsed on the Writ, the Defence need not be served until 14 days after a Statement of Claim has been served on the Defendant.

If the Defendant fails to serve his defence within the appropriate time, the Plaintiff may enter judgment against him without further notice.

3. A Stay of Execution against the Defendant's goods may be applied for where the Defendant is unable to pay the money for which any judgment is entered. If a Defendant to an action for a debt or liquidated demand (i.e. a fixed sum) who does not intend to contest the proceedings states, in answer to Question 3 in the Acknowledgment of Service, that he intends to apply for a stay, execution will be stayed for 14 days after his Acknowledgment, but he must, within that time, issue a Summons for a stay of execution, supported by an affidavit of his means. The affidavit should state any offer which the Defendant desires to make for payment of the money by instalments or otherwise.

Notes for Guidance

1. Each Defendant (if there are more than one) is required to complete an Acknowledgment of Service and return it to the Courts Office.
2. For the purpose of calculating the period of 14 days for acknowledging service, a writ served on the Defendant personally is treated as having been served on the day it was delivered to him.
3. Where the Defendant is sued in a name different from his own, the form must be completed by him with the addition in paragraph 1 of the words "sued as (the name stated on the Writ of Summons)".
4. Where the Defendant is a FIRM and an attorney is not instructed, the form must be completed by a PARTNER by name, with the addition in paragraph 1 of the description "Partner in the firm of (.....)" after his name.
5. Where the Defendant is sued as an individual TRADING IN A NAME OTHER THAN HIS OWN, the form must be completed by him with the addition in paragraph 1 of the description "trading as (.....)" after his name.
6. Where the Defendant is a LIMITED COMPANY the form must be completed by an Attorney or by someone authorised to act on behalf of the Company, but the Company can take no further step in the proceedings without an Attorney acting on its behalf.
7. Where the Defendant is a MINOR or a MENTAL PATIENT, the form must be completed by an Attorney acting for a guardian ad litem.
8. A Defendant acting in person may obtain help in completing the form at the Courts Office.
