THIS WRIT OF SUMMONS has been issued against you by the above-named Plaintiff in respect of the claim set out on the next page.

Within 14 days after the service of this Writ on you, counting the day of service, you must either satisfy the claim or return to the Court Office, PO Box 495, Grand Cayman, KY1-1106, Cayman Islands, the accompanying Acknowledgement of Service stating therein whether you intend to contest these proceedings.

If you fail to satisfy the claim or to return the Acknowledgement within the time stated, or if you return the Acknowledgement without stating therein an intention to contest the proceedings, the Plaintiff may proceed with the action and judgment may be entered against you forthwith without further notice.

STATEMENT OF CLAIM

1. The Plaintiff is and was at all material times a Class A Bank organised and carrying on business pursuant to the laws of the Cayman Islands. The Plaintiff's address for service is care of its attorneys, HSM Chambers, 68 Ford Street, PO Box 31726, George Town, Grand Cayman, KY1-1207, Cayman Islands.
2. Pursuant to a Certificate of Incorporation on Change of Name dated 28 July 2022, the Plaintiff changed its name from Fidelity Bank (Cayman) Limited to Proven Bank (Cayman) Limited. Its address for service remains the same.
3. The Defendant is an individual who resides in the Cayman Islands with the mailing address PO Box 214, Grand Cayman KY1-1301, Cayman Islands.
4. The Defendant entered into two separate agreements with the Plaintiff, one for a personal loan and the other for a credit card, the particulars of which will be laid out below. She has since defaulted on both loans and this Writ of Summons is being filed to claim for the sums owing under both FACILITIES.

Personal Loan Agreement

5. Pursuant to a Credit Facility Letter and Promissory Note both dated 7 March 2019, the Plaintiff agreed to advance to the Defendants the sum of CI\$42,000.00 plus interest thereon of 15% per annum to be repaid by monthly instalments over a period of 84 payments or, in the alternative, upon demand (the "Personal Loan Agreement").
6. In breach of the Personal Loan Agreement, the Defendant failed to pay the monthly instalments as and when due. Accordingly, the Plaintiff, through its attorneys, issued a Formal Demand letter dated 20 January 2021, which was personally served on the Defendant on 5 March 2021, demanding payment of the arrears under the said Personal Loan Agreement, failing which the entire outstanding balance would become due and owing.
7. The Defendants failed to comply with the Formal Demand letter and the Plaintiff has suffered loss and damage as a result.

8. Accordingly the Plaintiff claims the sum of CI\$47,738.76 under the Personal Loan Agreement, comprised of principal of CI\$37,994.96 and accrued interest of CI\$9,743.80, together with pre- and post-judgement interest from 25 January 2023 at the contractual rate of 15% per annum and continuing at the rate of CI\$15.61 per diem.

Credit Card Facility

9. On or around 1 September 2015, the Defendant entered into an agreement with the Plaintiff for a credit card (the “**Credit Card Facility**”). The terms of the Credit Agreement were, *inter alia*, as follows:
 - a. That the Plaintiff would advance credit to the Defendant;
 - b. That the Defendant would repay a minimum monthly amount of 5% of the advanced credit or US\$50.00, whichever was the greater;
 - c. That interest would accrue on the balance at the rate of 19% per annum; and
 - d. That the Defendant would be liable for the Plaintiff’s collection costs and legal fees in the event that the Defendant defaulted on the payment terms.
10. The Plaintiff advanced credit to the Defendant from time to time in accordance with the terms of the Credit Agreement.
11. In breach of the Credit Agreement, the Defendant defaulted upon the terms of repayment of the Credit Agreement and the Plaintiff has suffered loss and damage as a result.
12. Pursuant to a Formal Demand letter dated 22 September 2022, which was personally served on the Defendants on 29 September 2022, the Plaintiff demanded from the Defendant the outstanding sum due under the Credit Agreement.
13. The Defendants failed to comply with the Formal Demand letter and the Plaintiff suffered loss and damage as a result.

14. Accordingly, the Plaintiff claims the sum of US\$2,072.31 under the Credit Card Facility, together with pre- and post-judgment interest from 25 January 2023 at the contractual rate of 19% per annum and continuing at the rate of US\$1.08.
15. Alternatively, the Plaintiff claims pre- and post-judgment interest, on both facilities, in accordance with s.34 of the *Judicature Act (2021 Revision)* and the *Judgment Debts (Rates of Interest) Rules, 2021* at the rate of 8.38% for such period as the Court deems fit;

AND THE PLAINTIFF CLAIMS:

- a) The Outstanding sum on the Personal Loan Agreement of CI\$47,738.76.
- b) Pre- and post-judgment interest from 25 January 2023 at the contractual rate of 15% per annum and continuing at the rate of CI\$15.61 per diem in accordance with the terms of the Credit Card Facility;
- c) The Outstanding sum on the Credit Card Facility of US\$2,072.31.
- d) Pre- and post-judgment interest from 25 January 2023 at the contractual rate of 19% per annum and continuing at the rate of US\$1.08 per diem in accordance with the terms of the Credit Agreement;
- e) Alternatively, pre- and post-judgment interest, on both facilities, in accordance with s.34 of the *Judicature Act (2021 Revision)* and the *Judgment Debts (Rates of Interest) Rules, 2021* at the rate of 8.38% for such period as the Court deems fit;
- f) Costs; and
- g) Such further and other relief as this Court may deem just.

INDORSEMENT

The amount claimed in respect of the Personal Loan Agreement is CI\$47,738.76 and in respect of the Auto Loan Agreement is US\$2072.31. The amount of the filing fees to commence the proceeding is CI\$200.00 plus Ad Valorem in the sum of CI\$394.38. If, within the time for returning the acknowledgement of service, the defendants pay the plaintiff or its attorneys-at-law the total amount claimed in principal, interest and the costs of issuing the Writ of Summons, further proceedings will be stayed. The money must be paid to the plaintiff or to its attorneys-at-law.

INDORSEMENT REGARDING INTEREST

1. The contractual terms upon which interest is claimed are as set out at paragraphs 5 and 9 above;
2. The prescribed rate of interest on the Personal Loan Agreement is 15% and on the Credit Card Facility is 19% per annum;
3. The date from which interest is payable is 25 January 2023; and
4. The amount of interest accruing each day is CI\$15.61 on the Personal Loan Agreement and US\$1.08 on the Credit Card Facility.

**DIRECTIONS FOR ACKNOWLEDGMENT OF SERVICE
OF WRIT OF SUMMONS**

1. The accompanying form of *Acknowledgment of Service* should be completed by an Attorney acting on behalf of each Defendant or by each Defendant if acting in person.

After completion it must be delivered or sent by post to the Law Courts, PO Box 495 GT, Grand Cayman.

2. A Defendant who states in his Acknowledgment of Service that he intends to contest the proceedings *must also serve a defence* on the Attorney for the Plaintiff (or on the Plaintiff if acting in person).

If a Statement of Claim is indorsed on the Writ (i.e. the words "Statement of Claim" appear on the top of page 2), the Defence must be served within 14 days after the time for acknowledging service of the Writ, unless in the meantime a summons for judgment is served on the Defendant.

If the Statement of Claim is not indorsed on the Writ, the Defence need not be served until 14 days after a Statement of Claim has been served on the Defendant.

If the Defendant fails to serve his defence within the appropriate time, the Plaintiff may enter judgment against him without further notice.

3. A *Stay of Execution* against the Defendant's goods may be applied for where the Defendant is unable to pay the money for which any judgment is entered. If a Defendant to an action for a debt or liquidated demand (i.e. a fixed sum) who does not intend to contest the proceedings states, in answer to Question 3 in the Acknowledgment of Service, that he intends to apply for a stay, execution will be stayed for 14 days after his Acknowledgment, but he must, within that time, *issue a Summons* for a stay of execution, supported by an affidavit of his means. The affidavit should state any offer which the Defendant desires to make for payment of the money by instalments or otherwise.

Notes for Guidance

1. Each Defendant (if there are more than one) is required to complete an Acknowledgement of Service and return it to the Courts Office.
2. For the purpose of calculating the period of 14 days for acknowledging service, a writ served on the Defendant personally is treated as having been served on the day it was delivered to him.
3. Where the Defendant is sued in a name different from his own, the form must be completed by him with the addition in paragraph 1 of the words "sued as (*the name stated on the Writ of Summons*)".
4. Where the Defendant is a **FIRM** and an attorney is not instructed, the form must be completed by a **PARTNER** by name, with the addition in paragraph 1 of the description "Partner in the firm of (.....)" after his name.
5. Where the Defendant is sued as an individual **TRADING IN A NAME OTHER THAN HIS OWN**, the form must be completed by him with the addition in paragraph 1 of the description "trading as (.....)" after his name.
6. Where the Defendant is a **LIMITED COMPANY** the form must be completed by an Attorney or by someone authorised to act on behalf of the Company, but the Company can take no further step in the proceedings without an Attorney acting on its behalf.
7. Where the Defendant is a **MINOR** or a **MENTAL PATIENT**, the form must be completed by an Attorney acting for a guardian *ad litem*.
8. A Defendant acting in person may obtain help in completing the form at the Courts Office.
