**UPON** the application of the Plaintiff by way of Summons dated 6 February 2023 (the **Summons**)

**AND UPON** reading the Second Affidavit of Soumiya Pereira sworn on 6 February 2023 and Exhibit SP-3 thereto in support of the Summons

**AND UPON** hearing leading counsel for the Plaintiff

**IT IS ORDERED** that:

- 1 Pursuant to GCR O.14, r. 1, summary judgment be entered against the Defendant on the Plaintiff's Re-Amended Writ re-amended on 13 December 2022 (the **Re-Amended Writ**) in favour of the Plaintiff.

- 2 The judgment of the Court of First Instance of the Republic and Canton of Geneva in Switzerland dated 30 June 2016 be recognised in the Cayman Islands.
3. The Defendant shall pay the Plaintiff the following sums due at the date of this order:
  - (a) CHF 24,975,820, as ordered by the Court of First Instance of the Republic and Canton of Geneva in Switzerland by judgment dated 30 June 2016;
  - (b) Interest at a rate of 5% per annum running from 31 August 2016 to 16 May 2023 as ordered by the Court of First Instance of the Republic and Canton of Geneva in Switzerland by judgment dated 30 June 2016, in the sum of CHF 6,442,695.85; and
4. The Defendant shall thereafter pay interest on the sum of CHF 31,418,515.85 at the rate of 2% per annum pursuant to Section 34 of the Judicature Act (2021 Revision) and the Judgment Debts (Rate of Interest) Rules (2021 Revision).
5. The Defendant shall pay the Plaintiff's costs of the Re-Amended Writ and the Plaintiff's costs of the Summons on the standard basis to be taxed if not agreed.
