PARTICULARS OF CLAIM

1. The Defendant is and was at all material times a Cayman Islands licensed company carrying on business pursuant to the laws of the Cayman Islands. The Defendant’s registered office is located at The Grand Pavilion Commercial Center, 802 Oleander Way, West Bay Road, Grand Cayman KY1-1208.
2. Between May 2017 and March 2022, the Defendant issued six cheques to Cayman Islands Government for the payment of services, which were dishonoured by the bank and returned to the Government due to insufficient funds. The details of the dishonoured cheque are:

3. The total sum owed to the Cayman Islands Government is CI\$2,342.00.

6. As a result of the above, the Plaintiff is entitled to the relief claimed in this proceeding.
