The Joint Receivers' remuneration, including their costs, fees and disbursements for the period 1 April 2022 to 31 May 2023 (the **Period**) as set out in the Sixteenth Affidavit of John Paul Royle dated 15 June 2023, in the sum of US\$889,754.00 together with their additional fees, costs and disbursements in the sum of US\$241,608.78 incurred in the Period, be approved by the Court.
2. The Joint Receivers' remuneration, costs, fees and disbursements as approved by the Court be paid out of the assets of BH06.
3. The Joint Receivers' costs of and incidental to this Summons be paid out of the assets of BH06.
