**ORDER BY CONSENT**

**UPON** David Lickrish (the **Applicant**) submitting a proof of debt to the joint official liquidators (the **JOLs**) of North Sound Pharmaceuticals Inc. (in Official Liquidation) (the **Company**) on 24 August 2022 for a claim of US\$6,634,071.21

**AND UPON** the JOLs issuing a Notice of Rejection of Proof of Debt to the Applicant dated 10 May 2023, rejecting the Applicant's proof of debt in part (the **Notice of Rejection**)

**AND UPON** the Applicant filing a summons dated 30 May 2023 to appeal the Notice of Rejection (the **Appeal**)

**AND UPON** the application by the Applicant made by summons dated 29 June 2023 (the **Application**) for a declaration that the Appeal was made within the time prescribed by Order 16, rule 18(1) of the Companies Winding Up Rules (2023 Consolidation), or alternatively, for an extension of time to file the Appeal

**AND UPON** the JOLs confirming that they will not make or support any argument that the Appeal was not made within the time prescribed by CWR O.16, r.18(1)

**IT IS HEREBY ORDERED THAT:**

1. The Application is dismissed.
2. The JOLs shall file and serve any evidence in answer to the Appeal by 5pm on 8 August 2023.
3. The Applicant is to file and serve any evidence in reply by 5pm 25 August 2023.
4. The Appeal be listed for hearing on the next available date after 27 September 2023.
5. The parties are to exchange skeleton arguments for the Appeal no later than five business days before the hearing date of the Appeal.
6. The parties are to lodge hearing bundles with the Court electronically and in hardcopy no later than five business days before the hearing date of the Appeal.
7. No order as to costs of the Application as between the Applicant and the JOLs.
8. The JOLs' costs of and incidental to the Application be payable out of the assets of the Company as an expense of the liquidation.
