THIS PLAINT has been issued against you by the above-named Plaintiff in respect of the claim set out on the next page.

Within 14 days after service of this Plaint on you, counting the day of service, you must either satisfy the claim or return to the Court Office, PO Box 495 GT, George Town, Grand Cayman, the accompanying Acknowledgement of Service form stating therein whether you intend to contest this action. If you intend to defend the action, in whole or in part, you must set out **full particulars of your defence** in the space provided in the acknowledgement of Service form.

If you fail to satisfy the claim or fail to return the acknowledgeable of Service form containing full particulars of your defence, the Plaintiff may apply for a **default judgement** without any further notice to you.

PARTICULARS OF CLAIM

1. The Plaintiff is and was at all material times a company duly incorporated in the Cayman Islands in the business of providing short term unsecured loans.
2. The Defendant at the material times was a resident of the Cayman Islands.
3. By a written agreement dated 31 December 2021 and executed by the Defendant (hereinafter referred to as the “**Agreement**”), the Plaintiff agreed to advance the sum of CI\$ 600.00 to the Defendant.
4. The Defendant agreed to pay the Plaintiff the sum of CI\$ 780.00 being repayment of the sum advanced together with interest on or before 30 January 2022. The Defendant agreed to pay interest on the sum advanced of 7.5% per week.
5. Prior to entering into the Agreement, the Defendant provided to the Plaintiff evidence of employment in the Cayman Islands and proof of residential address.
6. The Defendant agreed to service via email. The Agreement, on page 2, permits any notice to be given via electronic mail at the email address provided by the Defendant being dangelacayman@gmail.com.
7. The Defendant agreed to pay all contractual costs on a full indemnity basis as set-out on pages 1 and 2 of the Agreement. Contractual costs, as at 9 August 2023, are CI\$ 862.50 and continuing.
8. The Defendant failed to pay the sum outstanding under the Agreement on 30 January 2022 or at all, despite demands for payment by the Plaintiff.
9. The Defendant agreed to interest pursuant to the Agreement at the rate of 7.5% per week. The contractual interest for the period 31 December 2021 to 9 August 2023 is CI\$ 3,773.57 continuing at a per diem rate of CI\$ 6.43.
10. A letter before action dated 22 March 2023 has been served in accordance with the contractual agreement for service by email on the Defendant dangelacayman@gmail.com. The Defendant was given 21 days of service of the letter before action to pay the amount due under the Agreement. The amount owed under the Agreement remains outstanding and there has been no response as of the date of this claim.
11. The Plaintiff is entitled to payment of the amount agreed upon between the parties under the Agreement including the principal sum advanced and interest.

AND the Plaintiff claims:

1. The sum of CI\$ 600.00.
2. Contractual costs in the amount of CI\$ 862.50 as at 9 August 2023 and continuing;
3. Contractual interest at a total of CI\$ 3,773.57, as at 9 August 2023, and continuing at a per diem rate of CI\$ 6.43.
4. Filing fees in the amount of CI\$ 25.00.
5. Pre and post judgment statutory interest in accordance with Judicature Act (2021 Revision) on all other sums at the rate prescribed by the rules.
