1. The JOLs' remuneration in the amount of US\$1,677,116.10 incurred during the period 14 September 2020 to 31 May 2022 be approved and paid out of the assets of the Company.

3. The JOLs costs of and incidental to this Summons be paid out of the assets of the Company as an expense of the official liquidation.
