ORDER

UPON the application of Mr Christopher Barnett Kennedy and Alexander Lawson of Alvarez & Marsal as Joint Official Liquidators (the “**JOLs**”) of Digit Limited (the “**Company**”) by summons dated 23 December 2022 coming on for a hearing on 20 January 2023 (the “**January Hearing**”)

AND UPON the January Hearing being generally adjourned

AND UPON the January Hearing being re-listed for a resumed hearing on 13 July 2023

AND UPON reading: i) the Second Affidavit of Christopher Barnett Kennedy sworn on 23 December 2022, together with its exhibit “CBK-2”; ii) the First Affidavit of Catherine Anderson-Bond sworn on 12 January 2023, together with its exhibit “CAB-1”; iii) the Third Affidavit of Christopher Barnett Kennedy sworn on 7 July 2023, together with its exhibit “CBK-3”; iv) the Fourth Affidavit of Christopher Barnett Kennedy sworn on 12 July 2023 together with its exhibit “CBK-4”; and, v) the JOLs’ updated written submissions re-dated 7 July 2023

AND UPON hearing Counsel for the JOLs and the Executors of the Estate of Ms Nafisa Hasan

IT IS HEREBY ORDERED THAT:

1. The JOLs are permitted to cause the Company not to defend or otherwise participate in proceedings issued in the English High Court of Justice, Business and Property Courts, Chancery Division entitled Nafisa Hasan v (1) Digit Limited; (2) EFG Private Bank (Channel Islands) Limited bearing claim number PT-2021-001004 (the “**High Court Proceedings**”) and be given permission (such permission to apply retrospectively) to take the steps which the JOLs have taken with respect to the High Court Proceedings to date.

2. The JOLs shall be permitted to cause the Company to lease the property registered in the name of the Company with title number NGL766504 at HM Land Registry and having the address of Fifth Floor, Flat 13, 42 Upper Berkeley Street, London W1H 5QL, United Kingdom and to enter into, execute, perform and take any action necessary to give effect to any agreement(s), subject to and provided that, the JOLs obtain the consent of Whiteswan (Worldwide) Limited, EFG Private Bank (Channel Islands) Limited, and the Estate of Ms Nafisa Hassan to enter into, execute and perform any such agreement(s).
3. The JOLs shall be permitted to enter into, execute and perform the funding agreement materially in the form exhibited to the Third Affidavit of Christopher Barnett Kennedy.
4. The JOLs are not required to file any interim reports and/or make any applications for the approval of their fees until the final dissolution hearing.
5. The JOLs' costs of and incidental to the Summons be paid out of the assets of the Company as an expense of the liquidation.


