

## PARTICULARS OF CLAIM

The Plaintiff was contracted to perform work on a Honda Prelude motorcar belonging to the Defendant. Partial work on the said motor car was completed and paid for. Further work was completed to the sum of Four Thousand and Seventy-Seven Cayman Islands Dollars and Twenty Cents (4,077.20kyd). Following a disagreement between the plaintiff, the defendant and the defendant's father, the defendant stopped the Plaintiff from completing further work on the said Honda Prelude and refused to pay the fees for the work already completed and demanded by letter.

AND the Plaintiff seeks:

- (1) The sum of 4,077.20kyd
- (2) Interest at the statutory rate of 8 and 3/8 % per year commencing January 12<sup>th</sup> 2023
- (3) Summary Court Costs
  - i. Filing cost 25.00kyd
  - ii. Fixed cost 150.00kyd
