ORDER

UPON THE APPLICATION OF Hugh Dickson of Grant Thornton Specialist Services (Cayman) Limited and Mark Byers of Grant Thornton UK LLP, the joint official liquidators (the "**Joint Official Liquidators**") of Saad Investments Company Limited (in Official Liquidation) (the "**Company**") by Summons dated 10 November 2023;

AND UPON READING the Fortieth Affidavit of Hugh Dickson sworn on 27 October 2023 ("**Dickson 40**") together with Exhibit "HD-40" and Walkers' letter dated 14 November 2023;

AND UPON hearing Counsel for the Company and the Joint Official Liquidators;

IT IS HEREBY ORDERED THAT:

1. Pursuant to section 110(2)(a) of the Companies Act (2023 Revision), the Joint Official Liquidators be and are hereby authorised to enter into and execute the

following documents in relation to the Samba Proceedings (as defined and detailed in Dickson 40):

- (a) the LOE (as defined and detailed in Dickson 40 and in the same or substantially similar terms as exhibited thereto) and to take such steps and execute such additional documents as might be necessary or desirable to fulfil the obligations contained in the LOE; and
 - (b) the CRA (as defined and detailed in Dickson 40 and in the same or substantially similar terms as exhibited thereto) and to take such steps and execute such additional documents as might be necessary or desirable to fulfil the obligations contained in the CRA.
2. Pursuant to Order 24, Rule 6 of the Companies Winding Up Rules (2023 Consolidation), the Summons and all evidence filed in support of it sealed and kept confidential and not be made open to inspection by any party or other person except with the prior leave of this Court until the date two years after the final determination of the Samba Proceedings by the Supreme Court of the United Kingdom (or any later date that the Court may order in the future).

3. The costs of and incidental to this Summons be costs in the winding up.
4. Liberty to apply.
