2. The Defendant is to file and serve an amended Summons by 4.00pm on 2 February 2024.
3. The Plaintiffs' evidence in response to the amended Summons shall be filed by 4.00pm on 16 February 2024.
4. The Defendant's evidence in reply shall be filed, if so advised, by 4.00pm on 23 February 2024.
5. Liberty to apply.
6. Costs in the cause.
