2. within one year of such Resealed Grant, arrange to have the assets comprising the said estate in the Cayman Islands administered according to the directions, if any, of the Court and arrange to file in the Probate Registry a general accounting for the whole of the assets of the said Cayman Islands estate.

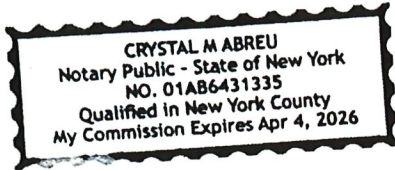



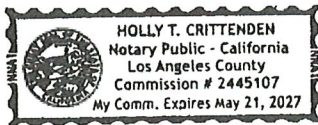
