1. Corbin Hedged Equity Fund, L.P. (**CHEF**) is substituted as the Second Respondent to these proceedings in place of Corbin Equity Fund, L.P., pursuant to GCR Order 15, rule 7(2) and/or the inherent jurisdiction of the Court.
2. Service of the *ex parte* Summons be dispensed with.
3. CHEF be required to pay the Petitioner's costs of and occasioned in relation to this Substitution Application on the standard basis to be taxed if not agreed.
