**PARTICULARS OF CLAIM**

(Here set out in numbered paragraphs the grounds upon which the Plaintiff claims that the Defendant is indebted to him or is liable to pay damages to him)

- 1) On December 27, 2023, the defendant was paid \$3,300 plus a subsequent amount of \$850, totalling to \$4,150 for a Honda Fits. It was originally agreed for the defendant to be paid 3,300 plus to receive the plaintiff's Toyota vitz(lic#166176) in exchange for a secondhand Honda Fits(lic#200471). Due to unforeseen circumstances the promised Honda fits had gotten into an accident. On 29/12/24 the defendant stated that he was expecting a shipment of 3 Honda fits cars on Jan 2, 2024. As such, the defendant stated he would give the plaintiff one of those Incoming cars, but \$1,000 more would need to be paid with the originally agreement. The plaintiff agreed to this proposal.
- 2) On January 2, 2024, no vehicle was provided. Subsequent agreed dates for defendant to provide vehicle or reimbursement was fulfilled. Starting on Jan 23, 2024, the matter was reported to officer Okoli at the GeorgeTown Police station. Arrangement was made for the defendant to provide reimbursement on Feb 4, 2024. Similarly, following dates were agreed to where partial payment could be made, but the defendant was non-compliant in providing reimbursement in both scenarios.
- 3) Plaintiff seeking reimbursement of \$4,150, filing fees of \$25 and \$100 for emotional distress damages.

AND the Plaintiff claims:

- 1 The sum of \$ 4,150.
- 2 Interest in the sum of \$ 25 calculated at the prescribed rate from to date.
- 3 Fixed costs of \$ 100, alternatively costs to be assessed.
