AFFIDAVIT IN SUPPORT OF APPLICATION FOR SPECIAL LEAVE

**THE SUCCESSION LAW, SECTION 4**

I, Kerry Whittaker of PO Box 125, Cayman Brac, Cayman Islands, KY2-2001, Cayman Islands hereby apply for special leave for a Grant of Letters of Administration in the estate of Stacey Wilson Tibbetts late of Stake Bay, Cayman Brac, Cayman Islands do MAKE OATH and SAY as follows:-

1. That Stacey Wilson Tibbetts died on the 20<sup>th</sup> day of January, 2004 instate.
2. That I wish to seek a Grant of Letters of Administration in the deceased estate being his lawful daughter.
3. My Mother Guelda Tibbetts the lawful widow of the deceased has consented for me to apply for the Grant of Letters of Administration on her behalf.
4. That I have not applied for a Grant of Letters of Administration in the deceased estate since his death. I was not aware that an application for a Grant of Letters must be obtained within six months of the death of the deceased. My mother also was not aware that such an application was required to be made for the Grant of Letters of Administration in a deceased person's estate.
5. That I have been advised that a Grant of Letters of Administration must be obtained within six months of the date of death of the deceased.
6. That I have also been informed that in order to deal with a deceased person's estate I have to first seek leave of the Grand Court in order to file

for a Grant of Letters of Administration as I have not done so within the six month period.

- 7. That the value of the deceased estate in the Cayman Islands is estimated at CI\$25,000.00 and consists of a small parcel of land and there is no personal estate.
- 8. That I seek leave to apply for a Grant of Letters of Administration for the reason given.
- 9. I ask this Honourable Court to grant me special leave so that I can apply for the Grant of Letters of Administration in the deceased estate notwithstanding that more than size months has elapsed since the death of the deceased, which grant will enable me to legally e in a position to windup the affairs of my late father’s estate in the Cayman Islands.





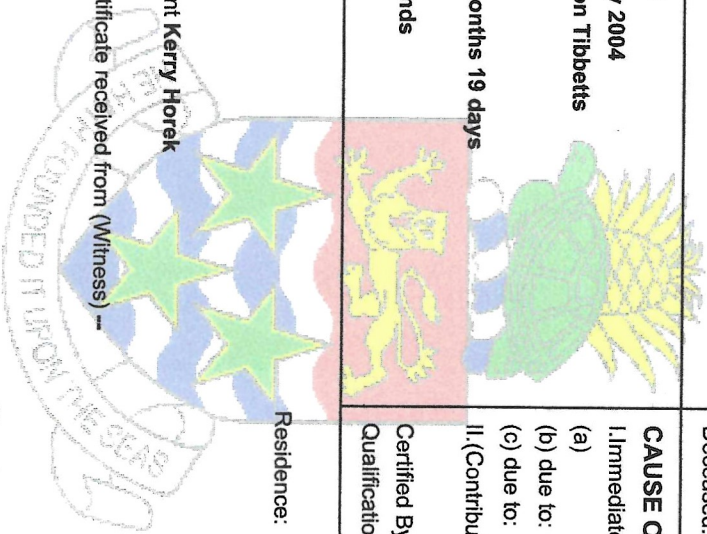
