The evidence filed in the Stay Summons shall be admissible in the Declaratory Relief Proceedings and the Jurisdiction Summons, and the evidence filed in the Declaratory Relief Proceedings and the Jurisdiction Summons shall be admissible in the Stay Summons (noting that an equivalent mirror Order will be made in the Declaratory Relief Proceedings). The parties have permission to refer to and rely on any such evidence at the Combined Hearing in relation to all matters before the Court at that hearing.
