- (a) I am one of the daughters of the deceased.
- (b) The deceased died at George Town Hospital, George Town, Grand Cayman, Cayman Islands on 12 March 2024. Attached to my affidavit is a certified copy of the Death Certificate of Judy Ann Bush.
- (c) The deceased died intestate.
- (d) The deceased was domiciled at 20 Sea Side Way, Savannah, Bodden Town, Grand Cayman, Cayman Islands.

- (e) The deceased was not known by any other name than her true name in connection with the ownership of any property at the time of her death.
- (f) The deceased's spouse predeceased her, Berkley Donovan Bush, appended below is a copy of the Death Certificate of Berkley Donovan Bush under Schedule 1.
- (g) The net value of the deceased estate is approximately CI\$1,218,000.
- (h) I have an interest in the said estate as one of the daughters of the deceased.
- (i) There is no minority or life interests which arise under the intestacy.

I undertake that in the event of such grant being made to myself, I will within one (1) year of such grant to myself, I will administer the said estate according to the directions, if any of the Court to file in the Probate Registry a general accounting for the whole of the assets of the said estate.

And I declare myself (and my successors) to be jointly and severally bound unto the Financial Secretary of the Islands in the sum of CI\$2,436,000.
