APPLICATION FOR GRANT OF PROBATE

We, Ivan Richard Wykeham Burges of 31 Satinwood Street, Spotts, Grand Cayman and William James Tyre Bagnall of 226 Shorewinds Trail, The Shores, West Bay, Grand Cayman, are the executors named in the will of Timothy Haddleton (the **Deceased**) formerly of 19 Silver Sands, West Bay Road, Grand Cayman who died in Grand Cayman on May 26, 2024.

We are both over the age of eighteen years and have not renounced probate.

- (b) within one year of such grant to us, administer the said estate according to the tenor of the will and the directions, if any, of this Honourable Court and file in the Probate Registry a general account accounting for the whole of the assets of the said estate.

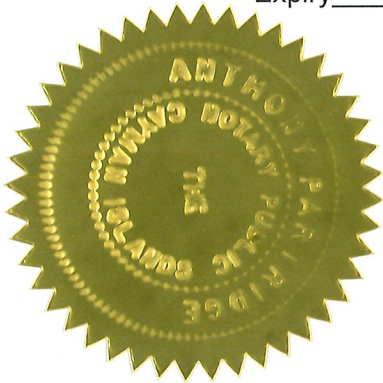
